OF NOTE: As a trial judge in *People v. Rincon-Pineda*, 14 Cal.3d 864 (1975), refused to instruct the jury that rape is a charge easily made and difficult to defend against as required by CALJIC 10.22; action upheld by California Supreme Court.

Many jurisdictions have since abolished such an instruction.

In 1980, created the sexual assault victim counselor privilege now embodied in Evidence Code section 1035-1036.2 and adopted by 18 other states.
